Over \$11 Million for Driver Wrongly Charged with Accident

Eleven years after she was wrongly charged with an accident that left her face down, unconscious and barely breathing in the middle of I-95, Jane Doe and her attorneys have finally resolved the last of her accident claims, which have over the years totaled in excess of \$11 million.

The crash report put all the blame on Jane, who could not dispute it since

she was comatose for several weeks and never regained any memory of the crash. Pajcic & Pajcic could not believe that a 36-year-old mother of two, who was a medical professional with a perfect driving record, could be as reckless as the crash report suggested.

The legal battle to unravel the enigma of how and why this tragedy occurred involved eight different lawsuits, nine mediations, one jury trial and seven different settlements.

The earliest recoveries came from the two tractor trailers which had struck Jane's car. The manufacturer of Jane's car also agreed to a substantial settlement because the seat and seat belt system allowed Jane to be ejected through a back window.

\$1.2 Million Recovery After Neurologist Ignores CT Scan



John and Jane Doe.

John and Jane Doe were a young couple in small town, South Georgia, living the good, old-fashioned Southern life. John coached their children in sports and worked with his mother at a Target distribution center. He and Jane had their own trailer on land adjoining her parents in the countryside outside Adel, Georgia.

Then John started having headaches. They got so bad he went to see his family physician who immediately referred him for a CT scan of the brain to rule out anything life threatening. The radiologist who looked at the CT scan reported significant abnormalities consistent with hydrocephalus.

Brandon Quaintance

One of Gary Pajcic's clients could not help but brag about his 15 year old grandson Brandon Quaintance, who was an honor roll student at Paxon High, Gary and Steve's alma mater Within a few weeks Brandon was working in the Pajcic & Pajcic copy room, demonstrating the poise and intelligence that, five years later, now makes him a valuable part of the front office reception team. Brandon is also a full-time UNF student majoring in English with plans to become a lawyer. He has shown the directorial instincts essential for a successful trial lawyer in his design and weekly production of the multi-media presentations at his church, St. Paul AME. Brandon's success is especially remarkable since he was diagnosed with sickle cell anemia at three months and even this year had to endure two extensive hospitalizations. To ease the stress Pajcic & Pajcic has given Brandon a full scholarship but he still insists on being at the office a few hours a day for the experience and comradery.

The major recoveries came after a breakthrough when Pajcic & Pajcic met with a traffic homicide investigator who had assisted in the investigation of the accident. Buried in his field notes and not a part of the final accident report were ten additional witness statements, including one from an armored car driver with a suspicious denial of involvement:

Pajcic & Pajcic deposed the driver and got a recorded statement from his shotgun passenger before adding the armored car company to the suit. Their admissions provided compelling evidence that the whole accident sequence had actually been started when the armored car suddenly cut in front of Jane and caused her to swerve and lose control of her car.

Jane's case against the armored car and its driver evolved into bad faith cases against their insurance companies when they refused to pay their policy limits on a timely basis. The final bad faith case was tried last summer and resulted in a jury verdict against the insurance company. The case settled later, shortly after the hearing on attorney's fees. Pajcic & Pajcic then negotiated the final settlement with the manufacturer of the armored car for leaving a blind spot in the passenger's side view mirror.

Jane is building a large, handicapped accessible house and will have a

lifetime of income, which will give her financial security and independence.

In a few months the headaches got so bad John had to go to the ER. John started having blackouts. Each time the neurologist diagnosed headaches and told John not to come back for three months.

Right before Christmas John collapsed on the job. He was rushed to the ER at a hospital which had no neurosurgeon on staff and would not call one of its neurologists at night.

The ER physician knew it was more serious than migraines. He ordered another CT scan and also a lumbar puncture, which is tragically dangerous for a patient with hydrocephalus. As a result John suffered a brain stem herniation and died Christmas Day, 2003.

Jane and the family were referred to Pajcic & Pajcic by a great aunt who had seen the work of Pajcic & Pajcic as a witness in a nursing home case. Experts retained by Pajcic & Pajcic not only criticized the neurologist and the hospital doctors, but also testified that John could have lived a normal life with timely treatment of his chronic hydrocephalus.

The case against the neurologist, who is now a professor at the University of South Alabama, was especially compelling.

He was not only so arrogant as to override the radiologist without even looking at the CT scan, but he also denied the films showed any significant abnormality when he finally looked at them during deposition.

Mediation adjourned with defendants offering \$1,050,000 and plaintiff insisting on \$1,200,000. Defendants finally agreed to plaintiff's demand one day before it was to expire. As a result of the

settlement the children have college funds, the family has a new home and sufficient monthly income to allow Jane to stay home and raise the children.

\$1.925 Million from ER Doctor for Prescribing Excessive Dosage

Jane Doe slipped in her bathtub and broke her arm. The ER doctor prescribed some pain pills and sent her home. When the arm was still hurting the next day, Jane went back to the ER and the same doctor changed her pills and added a pain patch.

The next morning when her sister and neighbor, Jane Roe, came over to drive

Jane Doe to the doctor, Jane Roe found Jane Doe unconscious and barely breathing. When Jane Roe contacted Pajcic & Pajcic about Jane Doe's case, she was in a nursing home, mentally confused and wheelchair bound.

How could all this happen from a broken arm?

Pajcic & Pajcic's investigation and medical research showed the pain patch to be the culprit. It was a 100 ug/h Duragesic (fentanyl) patch. Fentanyl patches are not really appropriate for traumatic injuries, but are usually reserved for long term, intractable pain such as with cancer.

hospital pharmacy had.

Fortunately, Jane Doe has continued to gradually improve. Although she has not been able to return to work or to driving,

Jane Doe is out of the wheelchair and will soon be living independently in a nice, new condominium with a good monthly income for life.

Gary Pajcic would be very proud to see his son Seth join the firm this January. Seth may be the baby boy, but at 6'4", 220 lbs no one pushes him around. Seth started on his varsity high school basketball team beginning in the eighth grade. Like his dad, Seth was also an all-state football player and Northeast Florida Scholar-Athlete but, believe it or not, at 260 he was not big enough for the Seminole offensive line. Seth ended up going to Sewanee, then got a Masters in political management from George Washington and his law degree from FSU. After two and a half vears and 22 jury trials. State Attorney Harry Shorstein says Seth is just as good as those other Pajcic stars he helped train and is ready to take on the big insurance companies. Seth and wife Kathleen had their first child Patrick a year ago and just bought the house next door to his oldest brother Curt, who now thinks his neighborhood is going to the dogs, especially since Seth's basset hound Owen has been known to bark late into the night.

Big Truck Case Settles Just Before Jury Selection for \$2.75 Million

The trucking company continued to fight liability to the very end even though the crash report showed its truck had plowed into the back of John Doe and seven other vehicles in rush hour traffic on I-95 in Jacksonville.

Pajcic & Pajcic welcomed the defense strategy because it opened the door for evidence concerning driver fatigue, the

primary cause of big truck crashes today. In this case the defendant driver had driven 1,700 miles to make deliveries in three cities over a six day period. The defendant trucking company was unable to produce the driver for deposition or trial.

> Rescue had to use the jaws of life to extract John from the cab of his

> > pick-up. John had transverse process fractures at five levels of his back. More seriously, he had a pelvic fracture which required screws and plates to hold the shattered bones together.

The severity of the injury to John's abdominal organs did not

manifest itself until months after the crash when

John had to go back to the ER with a complete bowel obstruction. The surgery removed part of his intestines and left him with adhesions and an ugly scar.

Despite the severity of his injuries John returned to work on a limited basis providing care-taking services for an affluent widow, who provided compelling testimony as to John's character and the impact of the accident. Indeed, Pajcic & Pajcic felt that the strongest part of the damages case was the appealing personality and character of not only John, but also his wife Jane.



Even though the case was hotly contested, Pajcic & Pajcic and the defense attorneys were able to maintain cordial relations and open communications throughout the litigation. This relationship was critical to the last minute negotiations. which resulted in a settlement of \$2.75 million in the courtroom as prospective jurors waited in the hallway outside.

Afterwards you continued your vigilant watch over my family and me until I was able to stand once more. I never told you how your personal acts of kindness and fellowship with my family and me touched my very soul.

A JUROR'S REMEMBRANCE

I met Mr. Pajcic at a lengthy trial when I served as a juror.

During the trial his professionalism and talent could not be missed, and neither could his genuine warmth and sincerity.

I appreciate having met this legend.

During the brief hospitalization before his death, the working diagnosis for Gary's sudden illness was acute meningoencephalitis. However, testing through the CDC and separate DNA testing have failed to identify any infectious agent. Analysis is continuing.
