#### INSURANCE COMPANY PAYS MANY TIMES INSURANCE POLICY LIMITS

It seemed like just another fight outside the iconic watering hole "Pete's Bar" at closing time, but this fight forever changed the life of an innocent bystander.

Josh Mathews worked nearby, was a regular at the bar, and was friends with everybody, including those on both sides of the fight. Josh had just left Pete's and encountered patrons fighting. He has no memory of anything that happened that night because he was sucker punched and his skull cracked on the cement.

### JURY AWARDS NEARLY \$19 MILLION FOLLOWING BAR FIGHT INSURANCE COMPANY PAYS MANY TIMES INSURANCE POLICY LIMITS

Josh had to have surgery on his brain and ended up with over \$1 million in medical bills. He can now walk, but he still often uses a cane and has trouble with stairs. He can understand what people say to him, but he is very frustrated that his brain injury has left him unable to speak more than a few words at a time. He can never be left unwatched.

Police records showed a long history of calls because of trouble at Pete's. All the other bars in the neighborhood hired off duty police to be out front at closing time, but not Pete's. Pete's may have had no security, but at least it had insurance. Pajcic & Pajcic gave the insurance company a comprehensive settlement package and an offer to settle the case for the \$1 million policy limits.

The company at first denied its policy covered the incident, but they abandoned that tactic and said Pete's was not responsible because the fight happened outside the door and because Josh was himself drunk.

The insurance company offered its limits before trial, but Josh and Pajcic and Pajcic decided it was too late. At trial, Pete's employees denied any involvement, but Pajcic & Pajcic played the police recordings to prove what really happened. On the recording, the Pete's doorman told the detective that he sent another patron, who he knew was drunk and a gifted fighter, to break up an argument. As soon as that patron stepped out the door, the fight erupted.



The jury found Pete's liable and returned a verdict for \$18,740,000. It also found Josh 40% at fault and the judge reduced the award accordingly. Since Pajcic & Pajcic had filed a proposal for settlement to Pete's, it was entitled to attorney's fees on top of the judgment.

The defense challenged the verdict, but on the eve of oral argument before the appellate court, agreed to settle for a slight discount off the judgment. The insurance company ended up paying the entire settlement even though it was way more than the policy limits.



The best thing that has happened to Josh since the injury has been his marriage to Lauren, his sweetheart from before. She and Josh moved back to Tennessee where her parents have been a tremendous help with Josh's care. Life will be much easier for all of them now that Josh can afford to pay for the care that allows the couple to live

independently in their own home. After the settlement, everyone came to Jacksonville to celebrate with the trial team. Josh went home with a smile on his face and a little something extra-the hat he had admired on Steve's head.


Wiley Clark spent his lifetime in law enforcement – he was described as a straight shooter you could always count on

Wiley was a chief investigator for the State Attorney's Office in the Gainesville and Starke area. He was in charge of a major drug unit and was pictured in Life Magazine working on a high profile case.

Family was always Wiley's top priority. He spent much of his free time with his grandchildren and was so happy that he and his wife Bonnie found their dream home on 20 acres in Alachua County. They loved working on the land and caring for their cows and donkeys.

One Sunday morning, Bonnie was getting ready to teach a Sunday school class at her church and Wiley was heading to meet a friend for breakfast. He never got there. He was driving on U.S. 301 in Hawthorne when a semi-tractor trailer for a world renowned retailer, inexplicably lost control, crossed the median and swerved directly into Wiley's pickup truck. Wiley did not survive.

Bonnie was devastated. The love of her life and husband of 38 years was gone in an instant. Eventually, she sought help from Starke attorney Dudley Hardy who

### MULTI-MILLION DOLLAR SETTLEMENT WITH INTERNATIONAL RETAILER FOLLOWING MAJOR SAFETY VIOLATIONS

ALL BECAUSE SOME COMPANY EMPLOYEES DID NOT WANT TO BE COLD

Elliott Alexander was just doing his job one day, delivering products to a world renowned retail store in Atlanta, when suddenly he was hit by a forklift and pinned to his own vehicle. Elliott's legs were shattered and doctors had to consider the possibility of a double amputation.

With a big name, big money company to sue, many law firms would have taken the easy road and accepted a quick settlement. We were not willing to give in so quickly. Our thorough investigation revealed a long list of critical company violations that added to the value of the case.

The forklift driver never should have been allowed to operate the machinery in the first place. The driver was blind in one eye and





eventually disclosed that his wife helped him pass his driving test because of his inability to read. In addition, the driver's view was obstructed because he overloaded the forklift with pallets to speed up the process. The driver admitted that management wanted the job done fast. To make matters worse, he wrapped plastic sheeting around the vehicle to keep him warm, which further clouded his view. The cold weather also kept his spotter inside, so no one was around to warn him of the impending danger. He also violated another company rule requiring him to drive the forklift in reverse if his vision was blocked. If he had

done that, he would have been able to see Elliott and the beeper on the forklift would have sounded, giving Elliott some warning.

All of these safety violations forced the company to do the right thing and fully compensate Elliott for all he had been through.

Doctors were able to save Elliott's legs. He spent more than a month hospitalized and in rehabilitation. After numerous surgeries, he still has plates, pins and other hardware holding the bones together.

He can never work again, or enjoy the simple pleasures of

sitting on the floor to play with his grandchildren, traveling with his wife or just living pain free. He is grateful to no longer have financial worries, but he would do anything to turn back the clock so that day would never have happened.





### A PURPOSEFUL PAJCIC PARTY

### CITY OF ATLANTIC BEACH DOES THE RIGHT THING RESULTING IN \$1 MILLION FOR TEENAGE BURN VICTIM

Anyone who goes to the beach to sunbathe should feel safe and secure in the sand. But for 13-year-old Jade Shaw a day of relaxation turned tragic and changed her life forever. Jade and her friend were getting some sun while lying on big colorful towels on the beach when suddenly a City of Atlantic Beach employee inexplicably drove his truck right over the girls.

The truck stopped in the sand on top of Jade as the hot underside of the truck seared her skin. Jade was taken by air ambulance to Shands burn unit in Gainesville

where she was treated for second and third degree burns over 30 percent of her body. Over the years she has endured multiple painful surgeries and procedures and will likely need more in the future.

Because a government entity was responsible, there are caps in place that would limit the amount we could recover for Jade to just \$200,000. Typically,



in order to secure something closer to what Jade would deserve, we would go through the claims bill process where we seek approval for a greater amount from the Florida Legislature.

This is a long and tedious process, but the firm has triumphed in all of our prior claims bill cases.

This time, Pajcic & Pajcic found

a way to prevail without a claims bill. The law provides an exception where there is insurance and Atlantic Beach had secured a \$1 million policy.

At first, the insurance company refused to pay, but Pajcic & Pajcic cited an appellate decision that would have forced the insurance company to pay several times the policy limits if it refused to tender the limits.

Fortunately, after significant litigation, both the city and its insurance company ultimately did the right thing, paying \$900,000, several times the sovereign cap. Another \$100,000 was available for Jade from a family uninsured motorist policy, to bring the total recovery to \$1,000,000.

Jade can now have some closure and focus on finishing high school and looking to her future. We also are glad to see the city has changed its policies when it comes to workers driving on the beach, so we are hopeful nothing like this will ever happen to anyone else.





#### PAJCIC PROFILE

Paralegal Nickey Williams-Kelly truly has a heart of gold. Once a month, she brings food and clothing to the homeless and helps kids in need. "We make sure they have clothing and hygiene products. We tutor children and we try to be a role model for them when their parents aren't around on a regular basis. If I could take away the poverty level in the whole city of Jacksonville I would." Nickey runs a charitable ministry through New Mount Pleasant Church where her husband is the pastor. Nickey has been known to do things spontaneously, like taking the jacket off her own back to give to a lady she saw shivering on a frigid day. Another example of a spur of the moment decision; she married her husband, Alexie Kelly, just 12 days after they met. Nickey says their love gets stronger each day. Fellow Pajcic co-worker Brenda Postell is credited with introducing them.

The Pajcic's long-time friend Julia Taylor was serving as honorary chair for the fundraiser. She called to see if they'd be willing to donate. They didn't hesitate, giving \$20,000, the largest single donation to date for GAL in the 4th Judicial Circuit.

It was personal for Anne as she was a GAL volunteer for six years. "Guardian ad Litem is a wonderful organization giving a voice to neglected children. I could see firsthand the important work done for our community's children."

### CONFIDENTIAL SETTLEMENTS

#### - TOTALING MORE THAN \$100 M

The public does not usually hear about settlements with car manufacturers, hospitals and international corporations because these settlements are typically confidential. In the last few years, Pajcic & Pajcic has reached confidential settlements totaling over \$100 million in several dozen such cases with settlements as high as \$20 million.

A half dozen of those cases and a fourth of the money recovered involved car roofs, defective air bags and seatbelts that could not withstand the



and the impact of collisions.



These crashworthiness cases are especially important at Pajcic & Pajcic

because they ultimately result in more safely designed cars and less paralysis and death.

Another big part of these confidential settlements are medical malpractice cases where Pajcic & Pajcic lawsuits have led to safer hospital procedures and fewer unqualified doctors working in them.





### THE LEGACY OF EL FARO

It was a gut wrenching drama that unfolded before our eyes. The cargo ship El Faro departed Jacksonville for a delivery in Puerto Rico. But the ship had antiquated weather forecasting equipment and El Faro headed straight into the path of Hurricane Joaquin. All 33 crew members were killed.



The Pajcic Firm represented two families with loved ones on the ship, but knowing there were dozens of other lawsuits being filed against the ship's owners, our firm took the lead and created a "joint prosecution agreement" to share certain information to benefit all of the victim's families. The Pajcic Firm served as the clearinghouse for multiple attorneys, all with the same goal of best serving our clients.

The results of all El Faro cases were confidential. The El Faro was covered in the media worldwide.

Our client Tina Riehm appeared on CBS's "60 Minutes" twice.



Her husband Jeremie was the third mate. Three books were written about the ship and Tina was interviewed for one of

them. She wanted to speak out on behalf of her brave husband, who was the rock of their family.

She has some comfort knowing that The Coast Guard Marine Board of Investigation recommended dozens of federal safety changes in hopes there will never be another tragedy like this again.

#### PAJCIC PROFILE

Janet Rodriquez was a newcomer to the Pajcic Firm in 2004, working in

the pre-suit department when co-workers convinced her to sign up for the Corporate Run. The firm was a sponsor of the downtown race and Janet gave it a try.
