4.3 MILLION DOLLAR VERDICT IN DISTRACTED DRIVING CASE

Julianna Dicks had just graduated from Clay High School, where she had been an honor student and a cheerleader.

She and her friends from church were returning from watching 4th of July fireworks in St. Augustine, but she never made it home that night. Another teenager, who was driving while distracted, made a left turn in an intersection right in the path of Julianna's car. Julianna was buckled in the backseat. She suffered injuries that would change her life forever.

Mock trials lead to \$3.2 Million Settlement in Medical Negligence Case

Mock trials are a standard part of trial preparation for Pajcic & Pajcic. Sometimes their results can be surprising – and so convincing that they make the real trial unnecessary.

Victor and Judy were just teenagers when they met at a parade in upstate New York, fell in love and married in 1962. They had four loving children. After a lifetime of hard work and government service, Victor and Judy retired to Florida where they hoped to enjoy their golden years. But medical negligence turned their lives upside down in the summer of 2015.

Julianna underwent emergency surgery that night and again the next day that included removing part of her intestines.

A relative of Julianna's is an attorney in Georgia,

who knew of the reputation of Pajcic & Pajcic and referred her to the firm. The insurance company did not meet Pajcic & Pajcic's offer of a presuit settlement for the policy limits. Then, after suit was filed, they turned down Pajcic & Pajcic's formal proposals for settlement, so the case proceeded to trial. The Duval County jury returned a verdict of \$4.327 million.

Finally, at a post-trial appellate mediation early this year, the insurance company agreed to a settlement of just under \$4 million, way more than its policy limits and the Pajcic proposals for settlement.

Julianna's long list of injuries include: elbow fractures, fractures of the orbital wall, and severe internal injuries.

Julianna was able to go to college, with the help of friends who carried her books for her. She is now an elementary school teacher.



Julianna survived, but both the physical scars and the emotional scars of that day will always remain.

She hopes this is a warning to all drivers to pay more attention. "Please, put the phone down."

Victor, experiencing the worst neck pain of his life, went to the emergency room. Despite blood tests consistent with an infection, he was diagnosed with arthritis and sent home by the attending doctor.

Within 16 hours of being sent home, Victor lost all feeling from his chest down. He was

rushed back to the hospital and surgery was performed. Upon cutting Victor open, doctors found a large infection in his cervical spine. Unfortunately for Victor, by the time of the surgery, the infection had grown so large that the damage done to his spinal cord was irreversible. Victor was left permanently paralyzed. Judy became his caregiver, bathing, lifting and feeding him.

The Capozzis called Pajcic & Pajcic about a bedsore that developed in a rehab facility. Pajcic and Pajcic's medical negligence team determined that Victor should not have become paralyzed in the first place. On the first visit, the hospital should have suspected an infection in Victor's cervical spine and initiated prompt antibiotic therapy, which would have



stopped the growth of the infection and Victor would still be walking today. The defense experts argued that the blood test results were nonspecific and that, even if infection had been diagnosed earlier, Victor's outcome would have been the same. Just prior to trial, Pajcic & Pajcic conducted six mock trials, which returned surprisingly favorable

results. Those were shared with the defense. Upon learning of the results, they agreed to pay \$3.2 million, \$700,000 more than Pajcic & Pajcic demanded two months earlier and almost \$2 million more than the defense's previous "highest and best" offer.

Victor and Judy were very happy to achieve a hard won settlement. Victor explained, "Judy will have the help she needs and deserves." They are also grateful that with some of the settlement money they have purchased a handicapped accessible van to make transportation much easier.





FLORIDA SUPREME COURT DECISION GIVES JUSTICE MORE THAN A DECADE AFTER DRUNK DRIVING DEATH

It took over a decade and a decision from the Florida Supreme Court before Jo Bowen could get civil justice for the drunk driving death of her husband, a Navy veteran.

The drunk driver drifted into the break down lane on I-95 hitting and killing Billy Bowen while he changed a tire on his boat trailer as his wife looked on helplessly. The drunk driver kept right on going. A Good Samaritan took chase. Many miles and several U-turns later Mary Christensen was tracked down. She was pinned into a parking lot and a video shows her kicking the shins of the arresting officers.

The insurance on the car was not nearly enough to cover the judgments from trial of \$3 million for compensatory damages, plus \$3 million for punitive damages.

But Ms. Christensen was by then a supposedly penniless convict and the jury did not think her multi-millionaire ex-husband's name on the title was enough to hold him liable.





The appellate court initially agreed by a vote of 2-1. Then, in a highly unusual move the Fifth District granted "en banc" rehearing and voted 5-3 to reverse itself. It certified the question to the Florida Supreme Court as one of great public importance. In a unanimous decision, the Florida Supreme Court reaffirmed Florida law, that a certificate title holder like Robert Christensen is liable for the permissive use of the vehicle by another person and therefore, was required to pay the verdict.

Along the years four grandchildren have blessed the life of Jo Bowen and the legacy of Billy.

GIVING BACK

Jo Bowen has always kept in touch with Jim St. John, the Good Samaritan who tracked down the woman who killed her husband. All these years later, when Jim found himself in need, Jo was there to help. Jim's two granddaughters suffer from a rare genetic disease called Leukodystrophy. Jo made a large contribution to help with the medical expenses. The Pajcic Firm then matched her donation tenfold. As Jo put it, "It felt good to be able to give something back to him. It felt good to say 'thank you' with more than just words. He stopped his life that day and stood up for our family and I'll always appreciate that so very much."

bushes at the clinic entrance. Indra Chhabra's Greyhound and Doberman chased the rooster, all while Indra was gripping tightly to the dogs' leashes. During the commotion, Indra fell, smashed her head, and lost consciousness.

The veterinarian's insurance company denied responsibility arguing that the rooster was a wild animal and that Indra contributed to her injuries by not letting go of the leashes. In the end, the insurance company accepted responsibility and the firm negotiated a fair settlement of \$1.25 million. The panel painstakingly reviewed evidence from a 1976 case and determined the men were wrongfully convicted. Raymond found it extremely rewarding to watch these men regain their freedom. Jailed since age 18, upon release, Nathan Myers registered to vote and proudly showed his registration card to Raymond during a recent meeting where the two got to visit for the first time since gaining his freedom.

More than \$5 Million for Fatal Motorcycle Wreck During Bike Week

Three good friends came down to St. Augustine to take in Bike Week, escape the Connecticut winter, and ride across Florida. Jim, Rodney and Kevin had spent the day at a Harley-Davidson dealership, collecting t-shirts and seeing the sights. As they rounded a curve on rural US1 in a safe, staggered formation, all of a sudden out of the darkness loomed a big delivery truck blocking both northbound lanes.





All of the bikers took immediate, evasive action. Kevin and Rodney skirted the front of the truck. Jim was not so lucky. He had a direct impact between the cab and the box and did not survive.

Their original attorney obtained a favorable statement from a key eyewitness who said that the bikers were not speeding and had no chance to avoid the truck. But when he demanded \$5 million to settle all the cases, the insurance company, relying on a 0.181 blood alcohol level of the motorcyclist who was killed, only offered \$325,000.

With the statute of limitations approaching, their attorney brought in Pajcic & Pajcic, whom he had watched win a big wrongful death trial in Flagler County. Pajcic & Pajcic turned the focus to the delivery company, which, like many "gig" companies denied any responsibility. Pajcic & Pajcic showed that the company demanded excessive hours and controlled every aspect of his employment.

After Pajcic & Pajcic survived 10 motions for summary judgment and the judge determined that punitive damages would be determined by the jury, the case resolved after a second mediation, for more than the original offer. While everyone was happy to settle the case, no one will ever fully recover from the tragedy and the loss of a friend, father and husband.

OVER \$25 MILLION FROM GIG COMPANIES

Many companies deny any responsibility for their drivers, claiming that they are not employees, but only doing a gig. Pajcic & Pajcic will not accept that fiction. In the last year and a half, Pajcic & Pajcic has made gig companies pay over \$25 million in damages to its clients.

\$1.5 MILLION SETTLEMENT FOR SCOOTER DRIVER AND HIS CANINE PASSENGER

J.J. Galasso was just driving his moped down A1A in Flagler County with his golden retriever "Doc" on board, when suddenly a driver hit them from behind.

The scooter caught on fire and J.J. suffered 3rd-degree burns on the lower half of his body and broken facial bones. Miraculously, Doc was not seriously injured, though his eyelashes and whiskers were singed.
